

**“GAROFALO INSPIRES”
FULL TERMS AND CONDITIONS**

Pastificio Lucio Garofalo SpA (hereinafter the “Promoter” or “Garofalo”) with registered offices in Via dei Pastai 42 - 80054 Gragnano (NA), Italy is organizing this Promotion, named “**Garofalo Inspires**”

This Promotion is open to restaurants located in the United Kingdom who are already clients of Pasta Garofalo or become clients of Pasta Garofalo during Promotion Period. Employees of the Promoter, and their immediate families, their agents or anyone professionally connected to this Promotion shall not be entitled to enter.

Purchase of Garofalo’s products is required to enter the Promotion.

The Promotion will be communicated to the participants through Garofalo Sales Representative network and through the Promotion Website www.garofaloinspires.com. Any person entering into or participating in this Promotion is deemed to have accepted and to be bound by these terms and conditions.

1. Promotion Period

Promotion is open from 00.01 UTC on 20th May 2019 until 23.59 UTC on 24th October 2019.
Winners’ selection on/by 31st October 2019.

2. Entry and participation

The present Promotion, open to restaurants in UK will be promoted through the promotion website www.garofaloinspires.com and through the network of Garofalo sales representative.

To be eligible to enter, restaurants shall be (or become) clients of Garofalo, and use Pasta Garofalo to create a new recipe, to be added in their menu.

More specifically, to enter restaurants will have to, during the Promotion Period:

- Go to www.garofaloinspires.com and enter the section dedicated to UK (unless they are automatically redirected)
- Download (without registering) the “Flyer template” available in PDF* and follow the instructions provided to realize a flyer with their own recipe, to be added in their menu: the PDF will have to be completed (manually or digitally) with the name and a short description of their recipe.
- Cook and plate their new recipe;
- Take a photo showing how they would serve it: the photo must clearly show the dish, as prepared and served and the flyer, realized and printed as a above.
- Go to www.garofaloinspires.com and register, with all the personal and restaurant’s details requested, the relevant information on their recipe. To finalize the registration, restaurants will also have to upload their photo (showing the dish and the flyer printed, as above explained).

*) please note that the flyer template may also be made available in paper form, by the sales representatives of Garofalo: restaurants will be allowed, in case they prefer to do so, to complete the paper form manually but in any case, participation will have to be submitted on the promotion website only, as described the paragraphs below.

IMPORTANT: the use of Pasta Garofalo in the dishes constitutes an essential eligibility requirement. The Promoter reserves the right, at any time, to verify the validity of entries and participants, including the participant’s identity, age and place of residence, and the existence of any orders placed by the participating restaurant, and to disqualify any participant who breaches these terms and conditions or tampers with the registration process or the Promotion.

All entries submitted by participating restaurants will be moderated and, if valid, will be made available on the promotion website www.garofaloinspires.com.

Please note that:

- It is the responsibility of each participant to obtain the permission of their employer where this is necessary for entry. By entering, each participant is deemed to have obtained, or to not require, such permission.

3. WINNERS' SELECTION

All entries submitted by entrants will be evaluated by a Panel of Judges selected by the Organizer and supervised by an independent judging subject. Recipes will be evaluated based on the following criteria:

- Ingredients used for the recipe;
- Originality of the recipe;
- Photo

Each member of the Jury will evaluate the recipes and assign a score for each of the above-mentioned criteria. The sum of the scores assigned to each entrant will be used to select 2 Winner(s).

Each winner will be awarded with

1 Trip to Italy for 1 person, to attend a Cooking Class with the Chef Niko Romito (valued approximately: 2.180 £).

4. FURTHER DETAILS ON THE PRIZE

Prize Details:

The winner will have the possibility to attend a Cooking Class with the Chef Niko Romito, taking place in Italy, at the "Accademia Niko Romito" in Castel di Sangro (AQ) between 24 and 29 November 2019 (dates may be subject to changes, depending on the Chef's availability, but will be confirmed to the winner at least 7 days in advance)

The prize includes:

- Return flights for the winner only, in economy class, with departure with the international airport nearest to the winner's residence and arrival in Rome;
- Transfers from Rome to the location of the Cooking Class
- Dedicated English Tutor chef
- 4 days of Professional Training at Accademia Niko Romito (27 hours)
- 5 overnight stays at 4 stars hotel
- 4 Dinners at Accademia Niko Romito Student Restaurant - 3 Michelin Stars

followed until reserves are available. The Promoter accepts no responsibility in the event that a restaurant cannot be contacted for any reason.
